Privacy Policy

This Privacy Policy explains how we collect your information through our website at onejunction.net ("Site"/"Website") and our Service. By using the Service or this Site, you acknowledge that you have read and understood this Privacy Policy.

Please review this Privacy Policy before using the this Site or Service. We evaluate our privacy policies to implement improvements and refinements from time to time. If we make material changes to this Privacy Policy we will notify you on this Site prior to the change becoming effective.

1. How And What Information We Collect

(1) Information you provide directly to us

When you use our Services, you may provide information directly to us. This information may include: your name and company name; email address; your business requirement.

(2) Cookies and Automated Information Collection

We and our service providers may use, place or read cookies or other technologies on your browser, and those practices are subject to their own policies. Cookies can be disabled at any time by changing your web browser's options to stop accepting cookies, to prompt you before accepting a cookie from the websites you visit or limit the type of cookies you allow. If you do not accept cookies, however, you may not be able to use all features, portions or functionalities of the Service.

We and our service providers use these log files, tags, and tracking technologies to collect and analyze certain kinds of technical information, including:

- 1 Information about your device: model, brand, language, screen resolution, operating system of your device version; network information (e.g. Wifi, 4G or Wired connection).
- ② Identifiers: Mac address; advertising identifiers (e.g., such as Apple's IDFA or Google's AAID); probabilistic identifiers included in the bid stream.
- ③ Browsing events: browser information (e.g. Safari or Chrome) usage; page or app URL; App usage and browsing information from apps a user has installed on their device; user Interactions:
- ④ We record your preferences regarding the processing of your information, based on the information you have received.

2. How We Use Your Information

Based on your consent or based on our legitimate interests, we may use your personal information for the following purposes:

- (1) to contact you and respond to your requirement;
- (2) to provide you with our service;
- (3) for analytic purposes;
- (4) to show personalized advertisements;
- (5) to personalize your visit to the Site and to assist you while you use the Site;

3. Disclosure of Your Information

- (1) We may use third-party to provide services to us. - (3) We may share personal information, in the event of a corporate transaction (e.g., sale of a substantial part of our business, merger, consolidation or asset sale). In the event of the above, our affiliated companies or acquiring company will assume the rights and obligations as described in this Privacy Policy.

4. Retention Of Your Information

We keep your information only so long as we need it to provide service to you and fulfill the purposes described in this policy. When we no longer need to use your information and there is no need for us to keep it to comply with our legal or regulatory obligations, we either remove it from our systems or depersonalize it so that we can't identity you.

5. Security Of Your Information

We use administrative, physical and technical safeguards to protect Personal Information. However, no method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, while we try to use reasonably acceptable means to protect your Personal Information, we cannot guarantee its absolute security or confidentiality.

6. Your Rights

You may have certain rights under applicable laws in relation to the personal information we hold about you, including:

- (1) You have the right to confirm whether and know the personal information we collected on you;
- (2) You have the right to correct inaccuracies in your personal information, taking into account the nature of the personal information and the purposes of the processing of your personal information.
